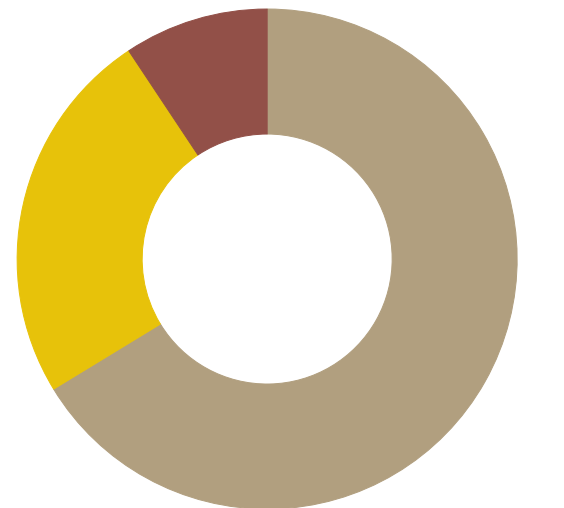

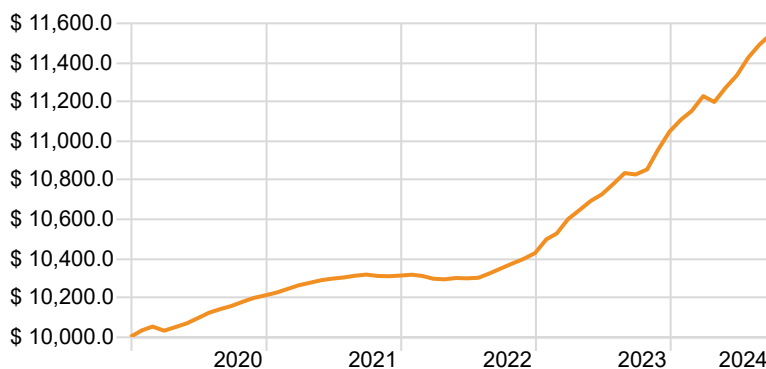

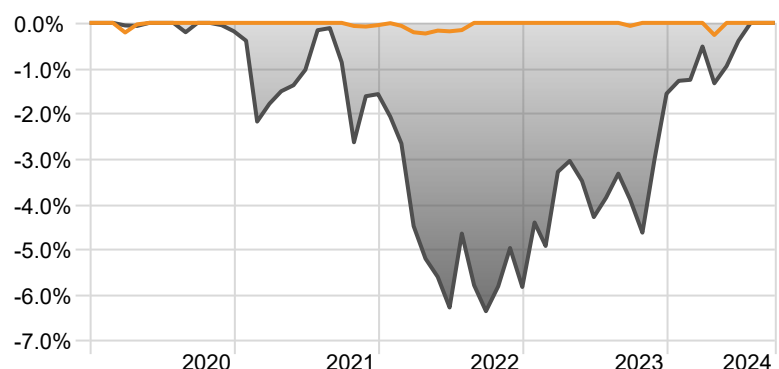


Growth of \$10,000 (since inception)
